# FREQUENTLY ASKED QUESTIONS PSU-Asingan Campus ETEEAP

#### What is ETEEAP?

ETEEAP or Expanded Education Equivalency and Accreditation Program (ETEEAP), being implemented pursuant to Executive Order #330 of 1996 , is a comprehensive educational assessment scheme which recognizes knowledge , skills and prior learning obtained by individuals from formal , non-formal education ,informal trainings and relevant work experiences .It employs equivalency competence standards and comprehensive assessment system involving written test, interview, skills ,demonstration ,and other creative assessment methodologies and completion of competency enrichment and other program requirements .A panel of assessors is constituted to determine the candidate's knowledge , skills ,and attitude relevant to a particular discipline , and consequently given equivalent credits toward the final granting of appropriate academic degree.

#### What are Program Offerings?

PSU was deputized as one of the higher education institution in Region 1 to implement the Expanded Tertiary Education Equivalency and Accreditation Program (ETEEAP) via five academic programs in accordance with policies stated in Section 5 and of 6

#### Executive Order #330, issued on May 10, 1996:

- Bachelor of Secondary Education Major in Mathematics, Science and English
- Bachelor of Elementary Education
- Bachelor of Industrial Technology

Mechanical Technology
Automotive Technology
Electronics and Computer Technology
Electrical Technology
Food Technology

## Who are qualified to apply?

The minimum qualification of applicants to the accreditation and equivalency program, in addition of being a Filipino citizen, should include the following:

- 1. Completion of secondary program as evidenced by a high school diploma ,or the Philippine Education Placement Test (PEPT) result equivalent to first year college .
- 2. Employment of an aggregate of at least five (5) years in the industry related to the academic degree program or discipline where equivalency of learning is sought.
- 3. At least twenty-five (25) years old of supported by an NSO authenticated birth certificate.

#### 4. Other Institutional Requirements:

a. ETEEAP prioritizes recruitment of applicants from the industry in the under graduate programs (BSE, BEEd and Bachelor of Industrial Technology).

### b. Residency Period

- Individual enrolled under the Program is required to have minimum residency of six (6) months. An enrollee could not apply for graduation, even he/she complied all the requirements, if the above residency period was not observed.
- c. Must have at least sixty (60) points upon evaluation of pertinent papers

#### What to prepare?

- School records (high school diploma ,or the Philippine Education Placement Test (PEPT) result equivalent to first year college)
- Certificate of employment
- All documents/ certificate of related trainings
